Dear readers of Green Budget News,

This is a special edition of Green Budget News to report on the Eighth Global Conference on Environmental Taxation, the GCET (<http://www.worldecotax.org/home.html>).

As you probably know, the conference was entitled **Innovation, Technology and Employment – Impacts of Environmental Fiscal Reform and other Market-Based Instruments** and took place in the Kardinal Wendel Haus in Munich, Germany, from 18th-20th October 2007.

With this conference, we hoped to **highlight less well-publicised aspects of EFR (Environmental Fiscal Reform)**, such as the **stimulation of innovation, the development of new technologies, and job creation**, rather than focussing on the more usual topics of political controversies and administrative details of the instrument debate. Identifying, analysing and understanding the positive effects of MBIs (Market-Based Instruments) – and communicating them – has a **vital role to play in the implementation of EFR** in the future to support a smooth transition to a sustainable economy.

For several reasons, we believe that the conference went some way towards doing just that.

Green Budget Germany Conference Resolution

Green Budget Germany presented a resolution to the conference and participants were invited to indicate their support for / against the resolution during the conference. The resolution, *Climate Protection Needs the Power of Market Instruments*, points out that **only by combining all existing effective instruments can we safeguard our diminishing chance of achieving a sustainable future** and calls on the **outgoing and incoming G8 presidencies, together with the countries of the Outreach dialogue, to contribute to an agreement on an efficient and consistent post-2012 climate emission trading system.**

More than 80% of conference participants, shown in the online signatories list, supported the resolution. Other visitors to the conference website may also sign the resolution if they wish.

The Resolution will be presented to the United Nations Climate Change Conference in Bali in December 2007, to the European Commission, and to individual governments (anyone interested in presenting the resolution to their national government is kindly requested to contact us at foes@foes.de).

Launch of Green Budget Europe

Encouraged by our experiences as an unusually specialized NGO in Germany, supporting economic instruments since 1994, and by the enormous resonance and recognition we received at the GCET 2007, **we are currently preparing the formation and launch of a platform to promote EFR and MBIs on the European level.** This new organisation will – for the first few years at least – operate as a project within Green Budget Germany and will function as a **competence centre and discussion platform, primarily addressing insiders such as the European Commission, government institutions, NGOs, industry associations, and experts.**

Conference Achievements

The conference call for papers http://www.worldcotax.org/call_for_papers.html distributed this spring elicited the submission of **well over 130 abstracts**, all of extremely high quality, and of which **more than 80 were presented at the conference** itself. The conference itself was attended by more than **300 participants, from a total of 49 different countries**, with guests from – amongst others – Mexico, Nicaragua, Costa Rica, Brazil, Argentina, India, Pakistan, the Solomon Islands, Thailand, Japan, China, Tanzania, Uganda, the Gambia, Egypt, Morocco, Ghana, as well of course as many guests from the USA, Canada, Australia, New Zealand and almost all European countries.

Keynote speakers included **Professor Klaus Töpfer**, former Executive Director of UNEP, and former German Environment Minister; **Professor Jacqueline McGlade**, Executive Director of the European Environment Agency; **Professor Norbert Walter**, Chief Economist of the Deutsche Bank; **Dr. Martin Búrsík**, Czech Vice Premier and Environment Minister; Swedish State Secretary for Tax Issues **Ingemar Hansson**, **Professor Ernst-Ulrich von Weizsäcker**, one of the founding fathers of environmental tax reform and former Member of German Parliament (MdB); and **Rae Kwon Chung**, Director of the Environment and Sustainable Development Division of UNESCAP.

Reflecting the success of the GCET 2007, we will be organising a **Special Conference on EFR for policy makers, politicians, business, and NGOs** back-to-back with the main GCET in **Singapore in 2008**, which has a more academic focus. Professor Klaus Töpfer awarded Adam Smith Prize

The keynote speaker at the conference was **Professor Klaus Töpfer**, former Federal Minister for Environment, Nature Conservation and Nuclear Safety, and **former Executive Director of the United Nations Environment Programme (UNEP)**. In his speech, he underlined the importance of energy taxation and **called for product prices to reflect their costs in terms of the use of natural resources** – otherwise, he pointed out, the developed world will continue to exploit the natural world today, while future generations and those living in the developing world will be the ones who pay for it. Furthermore, during the GCET press conference, he also praised awarding Al Gore the Nobel Peace Prize, referring to it as an acknowledgement of the fact that **climate policy is very much in the interests of global peace and security**.

Not only did Professor Töpfer give all conference participants food for thought and discussion with his presentation, he was also awarded the **Adam Smith Prize for Environmental Economic Policy** by GBG President Dr. Anselm Görres

The Conference in Detail

The first conference day focussed on the proven positive effects of EFR and other MBIs on innovation, technology and employment. The first plenary session highlighted some essential themes in this topic. **Jacqueline McGlade called for increased application of MBIs in the European Union** to ensure that the innovation advantage currently enjoyed in the EU resulting from its innovative use of MBIs to create incentives for innovation is not undermined by technological progress in China and the USA. **Kai Schlegelmilch gave a detailed description of the positive impacts of the German ETR on the German economy**, including increased public transport use, the creation of an incredible 250,000 jobs in new industries, concrete examples of innovative companies benefiting from the ETR in several ways, preferences in consumption patterns for fuel efficient cars, a boom in car-sharing, and for the first time ever decreased CO₂ emissions from the transport sector (after 50 years of steady growth)

On Friday 19th October, the second conference day, the first plenary session introduced the special workshop on **Environmental Fiscal Reform in Developing, Emerging and Transition Economies** hosted by the Federal Ministry for Economic Cooperation and Development (BMZ) and the Deutsche Gesellschaft für Technische Zusammenarbeit (GTZ). Representatives from the Ministry and the GTZ gave thought-provoking introductions to the topic, and **Rae Kwon Chung, Director of the Environment and Sustainable Development Division of UNESCAP**, gave a most interesting presentation on the state of environmental taxation in Asia. **He also stressed the importance of positive European examples, and noted that the German case is being analysed in some detail by policy makers in the region.** You can download Rae Kwon Chung's presentation at <http://www.worldecotax.org/downloads/Presentations/ChungRaeKwon.pdf>.

The Friday afternoon plenary session focussed on **EFR and energy**, with, amongst others, a speech from **Professor Ernst Ulrich von Weizsäcker**, currently Dean of Bren School for Environmental Science and Management and one of the major driving forces behind environmental taxation in Germany and elsewhere for many years, as well as co-founder of Green Budget Germany. Professor Weizsäcker called for annual energy and resource price increases in proportion to the resource productivity increases of the previous year. Such a long-term policy would create certainty of increasing resource prices and thus would prompt a 'race' towards higher resource productivity. Weizsäcker also looked at concrete ways of achieving this long-term policy, and discussed leading thinkers working on the problem of finding a global agreement today (<http://www.worldecotax.org/downloads/Presentations/Weizs%E4cker.pdf>).

One of the persons Professor Weizsäcker mentioned was **former economic adviser to George W. Bush and Harvard Economics Professor, Gregory Mankiw**, has also recently contributed to the New York Times, advising that international negotiations focus on the introduction of a global carbon tax, which has the advantage that revenues would remain within individual countries, in a marked contrast to probable outcomes of emission trading. Subsequent workshop sessions on energy analysed **price and tax incentives for renewable energy production, other renewables issues, energy efficiency, and reductions of emissions from energy**. A special workshop

in the energy sessions examined international cross-cutting issues, particularly WTO law, environmentally harmful subsidies, and the possibility for border tax adjustments.

The plenary and workshop sessions on Saturday, the 20th October, the last conference day, focussed on transport, and after a very lively presentation on the **Congestion Charge in London** – which was extremely popular amongst GCET participants! – workshops went on to discuss **biofuels, environmentally harmful transport subsidies, tolls and road user charging**, as well as a special workshop on global solutions to combat climate change (<http://www.worldcotax.org/abstracts-SATworkshop4.html>) and a fishbowl discussion on EFR in emerging, developing and transition economies.

The Saturday afternoon session was taken up with a **political discussion of EFR and implementation issues**, including presentations by **Czech Vice-Premier and Environment Minister Martin Bursik, Dr. Christoph Beier, Director General, Mediterranean Region, Europe, Central Asian Countries, GTZ** and **Swedish State Secretary for Tax Issues Ingemar Hansson**, as well as a session reflecting on the conference, including contributions by **John Hontelez, Secretary General of the European Environmental Bureau (EEB)** and **Alexandra Treckiak-Duval, Head of Development Co-operation Directorate's Policy Co-ordination Division, OECD**.
